

Sub.: Mandatory furnishing of PAN, KYC details and Nomination by holders of physical securities

Dear Shareholders (holding shares in physical form),

Your attention is hereby invited to SEBI circular number SEBI/HO/MIRSD/MIRSD-PoD-1/P/CIR/2023/37 dated 16th March, 2023, whereby SEBI has **mandated furnishing of PAN, Nomination, Contact details, Bank A/c details and Specimen signature**, in respect of all folio numbers where shares/securities are held in physical mode by investors.

Further, it is stated in the said Circular, that folios wherein any one of the cited documents/details are not furnished by such investors, on or after 1st October, 2023 then such folios shall be frozen by the Registrars and Share Transfer Agent of the Company (RTA).

The security holders whose folio have been frozen shall not be eligible to lodge grievance or avail any service request from the RTA unless complete documents/details specified above are provided by them. **Further, any payment including dividend, interest or redemption payment in respect of such frozen folios, can only be made through electronic mode with effect from 1st April, 2024, after complying with the requirements specified above.**

Such frozen securities shall be referred by the RTA or the Company to the administering authority under the Benami Transactions (Prohibitions) Act, 1988 and/or Prevention of Money Laundering Act, 2002, if it continues to remain frozen as on 31st December, 2025.

All shareholders who have not furnished the documents/details viz., PAN, E-mail address, mobile number, and bank account are requested to send the same to RTA through **Form ISR-1**, along with the necessary attachments / documents as stated in the form itself.

For appointing a nominee, shareholders are requested to furnish the **Form SH-13**.

In case shareholders do not wish to nominate any person with respect to the physical share(s) held by them, then please furnish the **Form ISR -3**.

In case of cancel / change nomination at a later date with respect to the physical share(s), then please furnish the **Form SH-14**.

All of the above stated forms can be downloaded from the website of the Company at www.voithpaperfabricsindia.com or from the website of Registrars at www.mcsregistrars.com

Also, please note that the **PAN to be furnished should be linked with Aadhaar**. In case the same is not so linked you are requested to do the same by June 30, 2023 or any other date as may be specified by Central Board of Direct Taxes (CBDT). **In the event such linkage is not done within the specified date, then your PAN will be deemed to be invalid and consequently your folio will be treated in the same manner as applicable in case of folios for which no PAN has been furnished.**

The requirement of existing investors to link their PAN with Aadhaar number is not applicable for Non-Resident Indians (NRI), Overseas Citizens of India (OCI) unless the same is specifically mandated by CBDT, Ministry of Finance or any other competent government body.
